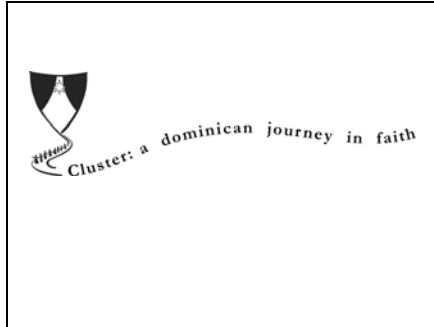


Slide 1



Cluster has truly been a Dominican journey in faith, as is imaged in our logo. On any journey, I think it always helps to look at where we've come from and where we're going in order to better appreciate where we are right now. Cluster Mission Statement
As members of the Cluster, we are committed to a process for the reconfiguration of Sister Congregations for Dominican life and Mission.

Congregational leaders began conversing about some kind of Cluster in 2000. Akron, Columbus, and St. Mary's New Orleans were the earliest participants in this conversation. By Spring of 2004, 7 congregations had committed themselves to participate in the Cluster process for the reconfiguration of sister congregations for Dominican life and mission: Akron, Columbus, Eucharistic Missionaries, Kentucky, Great Bend, Oxford, St. Mary's New Orleans. Cluster Coordinating Committee – March 2004

Leaders established a Cluster Coordinating Committee by the end of 2002. This committee planned a discernment process of seven cycles of meetings (congregational and inter-congregational) beginning in Fall 2003 and extending to the Spring of 2006. We had originally planned to have leadership present a final structure for decision-making at congregational chapters during the summer of 2006. However, as a result of recent congregational gatherings, Cluster leadership has decided to extend the timeline for decision-making to April 2007. This will allow more time for sisters to process the options for reconfiguration at congregational and pre-chapter meetings. (CLICK)

The Cluster Coordinating Committee established the following subcommittees to work on various aspects of the process: Documents and Government Structures, Congregational Histories, Reconfiguration, Prayer and Ritual, Communications, Sponsored Ministries, and Resources. Each subcommittee has representatives from each of the Cluster congregations and has made significant contributions to the Cluster discernment process. We owe a debt of gratitude to the sisters who serve on these subcommittees.

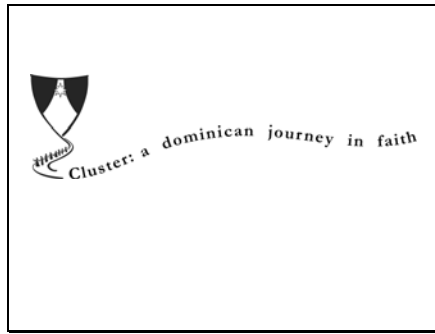

In conclusion, I would like to recall to mind the spiritual dimension of what we're about here. We are here to communally discern the future direction of Cluster reconfiguration. We are here to consider the common good, not just for the members of our own congregation, but the common good for all seven congregations, including future members who are not presently a part of us.

I encourage you to reflect on Carole Shinnick's words expressing the reasons for her own province's reconfiguration: "We were doing this as a communal generative act, creating a future some of us will never see . . . the effort of restructuring is about stewarding the mission for future generations."

Cluster is all about consolidating our resources so that future generations of Dominican Sisters will have a stronger foundation to enable their mission to continue. Let us trust that the Spirit who has brought us to this day will not leave us, but will provide what we need in insight, creativity and courage. Our sacred stories have shown us over and over that God will provide what we need to do God's work and preach God's word. (END)
